New committees were assigned for the coming year. Street Committee is Louth and Lare; Parks and Recreation is Hobbs and whoever will be chosen as the newcouncilman to fill Ruen's vacant seat; Safety and Police is Price and Leiter.

The council voted Robert Louth as the new council president. It was unanimously passed by council vote. A motion was made to retain Martin Burchfield as city solicitor. The council also voted on the services of Kim Coil as custodian of the city building. The services of Tom Evans for the purpose of snow removal was voted and passed by council.

The presentation of appropriations were read and unanimously passed by a roll call vote.

New business of selecting a replacement for Ruen's vacant council seat was discussed. Jeff Coil was nominated and appointed by council to that position.

Council will be changing its meeting time to 7 p.m. for the next few months to allow time for one of its members to attend the meetings from out-of-town business.

Ruen then congratulated Linda Fisher on her lengthy service to the community and wished her good fortune on her future endeavors. He presented her with a plaque commemorating her years of service as mayor of the village.

"It has been an honor to have served the village of Venedocia as mayor for 16 years," Fisher said. "I had a good working relationship with the village council. Over these years we have updated our streets, alleys and parks."
