### **Children and Youth:**

The junior choir divided into two groups for the singing, which made Wednesdays a little less chaotic around the church. The dedication of the adult volunteers who keep the program running smoothly is truly a wonderful blessing.

Vacation Bible School tried a new program this year, which was well received by the teachers and the children involved.

The confirmation program has been changed, and ten enthusiastic 6th and 7th graders began classes in the Fall.

### **Ministry:**

We celebrated the baptism of 3 babies, and the resurrection of 5 members. Together we supported one another in illness and sorrow.

### **Mission:**

We expanded our mission work as we shared the enthusiasm of Chad and Andi Irwin as they set out in the mission field of South America. We responded to the needs of the growing number of hungry in Van Wert County by deciding to collect canned goods all year. We supported young mothers through contributing baby articles to the Pregnancy Crisis Center in Van Wert.

### **Financial:**

The congregation more than met the growth in the budget with giving this past year, giving us a nice balance in the general fund to begin 2001.

### **Administration and Communication:**

An office was set up in the church, and Dana Taylor settled into the routine of work as the church secretary. It was gratifying to see how quickly the congregation began to stop by the office to check with her or give her information. The majority of members promptly returned their member information forms, helping us to build a database that will make statistical reports easier and will enable us to target certain groups for mailings. The *Sounds of Salem* is becoming more established, with more complete information on the upcoming events within the life of Salem Church.

We have continued to build on the foundation of our faith and our heritage as we look to the future and the opportunities God continues to provide.
